- 1. Mr Robert Ellis was present during the discussion of his proposal for a trapper to be employed. Mr Ellis made the following comments: -
 - Does not believe the aerial 1080 baiting is as effective as it used to be;
 - Along with his brother, they have already shot over 80 dogs this year with all forms submitted to Council with locations;
 - Recommended funding should be made available for a trapper and less funding for aerial baiting;
 - Recommended trapping for the first 4 months of the year and the last three months;

Ben Ogg

Agreed, trapping has been very successful in the past couple of months and would like to source outside funding specifically for trapping.

Leah Mitchell

Asked Mr Ellis what pay rate would be expected if he were to become the Council trapper.

Robert Ellis

Responded, suggesting a day rate of \$300 + \$100 per dog. Cost recovery is important.

Ben Ogg

This financial year funds are spent, however, this is a good opportunity to get the services of a good trapper.

Shane Axford

The Committee needs to focus on getting outside funding for a trapper and the \$100/dog rate needs to stay in place.

Robert Ellis

Suggested, ground baiting and save \$34, 000 on aerial baiting.

The Chair thank Mr Ellis for attending and putting forward his trapper proposal.

6 UPDATE ON DATA GATHERING

Michael Kaminski

Has been trialing a thermal camera, however there is currently too much heat in the ground to use to full potential. Would like to test infra-red sensors to monitor and track animals, however requires landowner's approval before entering properties. OTB is willing to fund the project. The main issue will be gaining access to properties.

The Committee will be having a public meeting in August, property access for monitoring sensors could be tabled.
