5 BUSINESS ARISING OUT OF PREVIOUS MEETING

6 SPECIAL GUESTS

Mrs Nerida Henwood

- Explained from a graziers prospective how the grasshoppers have effected their land. She also explained how the current grasshoppers are effecting the seeding and regrowth of the country.

Mr Tim East

- Spoke about his thoughts of how the grasshoppers are effecting future grass growth. Tim has received a large amount of rain this year although the grass hasn't seeded due to the grassshopper situation.

Mr Simon Williams

- Central mapping satilite goes over every 7 days surveying the land.
- Seeding issues caused by grasshoppers.
- Land owners will not get a resolution until they cover all areas.
- Mister spraying is killing them although they are returning because of favourable areas.

Presentation regarding the Diamantina area

- 2019 Moonsoonal event supported all the programs over the past two years although they are coming to an end in June 2022.
- One program left to cover the next 2 years.
- DCQ have been very dedicated to the Winton Shire.
- Very impressed with how proactive the land owners have been over the years. 350 land owners are actioning the issues.
- DCQ have been focusing on Winton Shire, Flinders Shire, Longreach and Barcaldine to knock out the core seeding areas leaving broad light areas left.

8 ITEMS FOR DISCUSSION

8.1 RURAL ROADS UPDATE

Council group operations manager provided the group with an update on the Rural Roads:

- 196 grids completed, they have just started back at work from Christmas period. The grid contractors are employed through GBA therfore we cannot give them work directives.
- Peter White noted that the time taking to clean the grids is unacceptable.
- Currently reviewing roads from recent rainfall.

Brett Elliott

Complimented the current conditions of the roads and council are doing a good job maintaning them.

Cr Cathy White gave a breifing on the road data that has been collected on the Jundah road.

8.2 STOCK ROUTE UPDATE

Council Rural Service Manager provided the group with an update on the Stock Routes Department:

- Currently completing funding work.
- Awaiting link slabs to arrive for the troughs.
- Have not applied for any state funding due to still completing current.
- One job has been removed from funding works due to not having the correct measurments.
- Sprayign has been ongoing.
- Common muster still cannot happen due to the policy needing to be changed and awaiting Stock Squad to conduct the muster as it will be a forced muster.

8.3 STOCK ROUTE POLICY

- Cr Gavin Baskett gave a verbal update regarding the 8 recommendations that are going through parliament the week to be decided.
- LGAQ 5 options to increase the fees.

10 GENERAL BUSINESS

Cr Cathy White

- Concerned about the rural addressing signs.

Cr Gavin Baskett

- Advised Cr White that there is money in the budget to update the rural addressing signs and provide emergency services with IPads.
- National Resilience and Recovery Agency Board have a working group up and running in conjunction with DAF.
- Received information from Jenny Neilson regarding emergency approved chemical. As other chemicals are tied up with the local commissions and not available for commercial sale due to the harm caused to other insects.
- 77 Water agreements have been sent out and only 5 returned.

John Paine

- Large grasshoppers arrived in October 2021 and have hung around until the recent rainfall. Have spotted some large grasshoppers after the recent rain.
- Shared his concerns with the exclusion fencing that has been put up on his boundary, not to high standards.

Phillipa Whitehead

- Have discovered that a different species of grasshoppers on their land that don't fly. Although they only ate certain parts of there paddocks.
- Recently spotted the little brown grasshoppers.

Brett Elliott

- A rat plague cleaned out the grasshoppers.
- Found that the grasshoppers like the shorter grasss more then the long thick patches.
- 2008-2022 the grasshoppers numbers haven't changed.
- Noticed the grass did not grow back in a paddock that had a large number of grashoppers over the years.
- Nargon access road has one creek crossing that needs a base in the bottom of the creek.

Peter White

- Noticed the grasshoppers arrive one week before it rains.
- Has concerns regarding the Fermoy access road being graded and has found gates left open after the contractors have been through.

Cr Tina Elliott

- Sugested that the community looked into running a campaign for awareness of ruber vine.

Simon Williams

- A new chemical has been released through BAYA trials altough it is looking very successful.
- Struggling with land owner participation in prickly acacia containment althought the programs and training are on offer.

Cr Anne Seymour

- Questioned why the Indian Lover Grass is slashed on the side of the road and not sprayed?

Cr Frank Standfast

- Explained the side of the road is not sprayed as it is an Enviromental issue.
- Rotary hay concerns as it is a fire hazard.

Geoff Cox

- Rural Lands are investigating Balistic Injection Training to offer to rural land holders.
