Informal Committee discussions were held regarding the budget. Meat from Townsville is costing around \$7.00/kg. The Committee does not have available funds to support a full second baiting in April 2022. A suggestion was to increase or add \$500 to the rural rate levy or a tiered scale charge per hectare.

Brett Elliot

Some areas are exclusion fenced and therefore shouldn't require a levy.

John Banning presented the MLA Market Information Report and noted the increase of stock prices since the start of the Winton Wild Dog Committee.

Cathy White

The participation rate has decreased and the message needs to be shared regarding the importance of participation at baiting time.
