Terms and Conditions

The After School Youth Program is operated by Winton Shire Council and coordinated by Council's Youth Support, Sport & Recreation Officer.

The Winton After School Youth Program aims to provide a safe and supportive environment, whereby Winton's young people aged between 8 and 25 years can participate in a variety of programs and events offered.

The goals of the After School Youth Program are:

- To build strong and vibrant Young People.
- To provide a safe, supportive, and non-judgmental service.
- To provide good role models for young people.
- To provide programs and activities for young people, that promote health and wellbeing.
- To assist young people in developing life skills and to enhance their positive decision making.

Attendance

A Child/ren can only attend these After School Youth Programs when this Agreement form has been completed, returned to Council, and approved by the Winton Shire Council Youth, Sport & Recreation Officer.

Winton Shire Council cannot compel a child / young person to stay on the premises if they choose to leave. Council commits to contacting a Parent / Guardian if a child / young person leaves the premises.

If you or any of your family feel unwell or are sick, please do not attend this service.

Temperature checks may be carried out on arrival.

Transport to the After School Youth Program

Winton Shire Council requires that a Parent / Guardian (adult) drop off and sign in and sign out and pick up their child/ren for each service.

Council does not provide transport for this service.

Parental permission to self-sign in and out:

In order to accommodate parents whose children self-transport to Council's Program, a parent can authorise their child/ren to sign in and sign out on their own behalf.

Alcohol

Winton Shire Council does not support ANY form of consumption of alcohol or the possession of alcohol at the Program location or during activities.

Drugs

Winton Shire Council does not support ANY form of consumption or possession of illicit drugs at the Program location or during activities.

Smoking

Winton Shire Council does not support children / young people smoking or possession of cigarettes at any time at the Program location or during activities.

Evacuation

All children are requested to respect their peers, and the Program Officers / Supervisors.

Swearing, bullying and any form of violence will not be tolerated.

Personal belongings

All children are responsible for their own belongings. Care should be taken with money and valuables; that is, phones, wallets etc. **If you don't need it, don't bring it.**

Use of computers and wi-fi

Internet access may be provided by the for certain activities (that is, Winton Library). Guidelines for internet access include:

- Never give out your personal information online; for example, phone number, address.
- Never send your photo to anyone online.
- Advise the After School Youth Program Officer / Supervisor if when using the internet, it makes you feel uncomfortable, scared, or upset.
- Advise the After School Youth Program Officer / Supervisor of any inappropriate messages you may receive.
- Do NOT use any Chat Rooms.
- Be polite to other users.
- Never use any Adult 18+ sites.
- Do not download any music or movies illegally.

Directions from the After School Youth Program Officer / Supervisor

All children are to take directions from the After School Youth Program Officer / Supervisor whilst at a After School Youth Program location and during associated activities.

Any breaches to these Policies, may result in the removal of the child/ren from the Winton Shire Council After School Youth Program.
