It is also to be remembered that the Board also has a function under Commonwealth Law to administer the Trust Funds. This requires each Board member and Secretary to be registered with ASIC. In closing, I would like to once again acknowledge the important relationship we have with the Winton & District Historical Society. Their displays give our Centre a real point of difference for visitors. We welcome Janice Evert as a Director. Janice joins Robyn as representatives of that organisation.
