All costs above \$300 will be an additional expense to the applicant; Plaque design requires signed approval before the order can be processed; and Plaques require pre-payment to Council before the order can be processed.
Monumental Section	<ul style="list-style-type: none"> Plaques can be designed to any size depending on the client's requirements; Plaque design requires signed approval before the order can be processed; The applicant is responsible for plaque costs; Plaque requires pre-payment to Council before the order can be processed; and Purchase and installation of concrete plinths and/or granite blocks incur an additional cost of \$450 (Current Fees and Charges).
