13.3 RAY HERMANN STATUE - INSTALLATION COSTS

SUMMARY

The Ray Hermann Statue Project has been delivered as a joint initiative between Winton Shire Council and the Diamantina Rodeo & Campdraft Association (DRCA), supported by combined financial and in-kind contributions. As at 31 July 2025, Council has contributed \$90,000 and DRCA \$58,820.12, alongside further in-kind support from both organisations. The statue was unveiled on 23 September 2025, with installation costs amounting to \$8,062.88. It is proposed that Council absorb these installation costs, recognising them as part of Council's total commitment to the project.

13.4 DONATION OF BANJO PATERSON STATUE FROM ALF AND SHARON CANTRELL**SUMMARY**

Winton Shire Council has been approached by Alf and Sharon Cantrell, formerly of the *Banjo Paterson More Than a Poet Museum* in Yeoval, New South Wales, regarding the donation of a statue of Banjo Paterson in World War I uniform for installation at the Waltzing Matilda Centre. With the permanent closure of the museum, the initial offer was made to members of the Waltzing Matilda Centre Ltd Board, who have subsequently referred the matter to Council for consideration.

It is proposed that the statue be installed in the vicinity of the outdoor Walkway of Honour at the Waltzing Matilda Centre. The project is intended to be funded through the Waltzing Matilda Centre Ltd Board, and subject to Council's support, the proposal will be referred back to the Board for formal ratification.

The North Queensland Recovery and Resilience Package (NQRRP) helps local communities recover from, and prepare for, future floods. 13.6 LGAQ SPECIAL GENERAL MEETING 17 DECEMBER 2025 - STATE GOVERNMENT'S PROPOSED AMENDMENT TO S155 LOCAL GOVERNMENT ACT 2009**SUMMARY**

The Local Government Association of Queensland (LGAQ) has issued formal notification of a Special General Meeting to be conducted by postal vote, closing 5.00pm 17 December 2025. The purpose of the vote is to seek the views of member councils in response to proposed amendments to section 155 of the *Local Government Act 2009* under the *Local Government (Empowering Councils) and Other Legislation Amendment Bill 2025*.

The proposed amendment would require Mayors and Councillors to automatically vacate their position upon nomination as a candidate for Queensland State Parliament. This represents a departure from the current arrangement, under which office is only vacated if the candidate is successfully elected.

The LGAQ motion proposes to maintain its longstanding member policy position (held since 2012) that Councillors should be able to nominate for State Parliament without resignation. A vote **FOR** supports maintaining this position; a vote **AGAINST** supports the proposed legislative change.

Given the implications for local representation, continuity and democratic participation, this report proposes that Winton Shire Council vote **FOR** the motion.
