**Dog Registration information**

- All domestic dog over the age of 12 weeks must be registered with Winton Shire Council
- Registration should not be confused with microchipping. These are two separate forms of identification.
- Microchipping of all domestic dogs is compulsory and a requirement when submitting this application.
- If the dog owner is claiming any concessions, evidence must be supplied to be eligible for a concession discount – that is, current Pension Card, desexing certificate or Assistance Dog Certification, etc.
- If the dog owner is claiming a fee exemption for a Guide, Hearing, or Assistance Dog, evidence in the form of certification as per the Guide, Hearing and Assistance Dogs Act 2009 is required.
- The owner of the dog/s must advise Winton Shire Council within 7 days of any change to the information provided on this Registration Application.
